4.1 Three Bid System Tender

The bids shall be in three separate parts containing i) .Tender Fee & EMD ii) .Technical and iii) .Commercial Bid. 4.2 TERMS AND CONDITIONS

4.2.1. Erasures or Alterations and Signing of Tender Offers

The original and a copy of the Tender Offer shall be typed or written in ink and shall be signed by the Bidder or a person or persons duly authorized in writing to bind the Bidder to the Contract. Such authorization shall be indicated by power of attorney on a stamp paper accompanying the tender offer. All pages of the Tender Offer, except for an amended printed literature, shall be initialled by the person or persons signing the Tender Offer. 4.2.2 Completeness of Technical Offer

The service provider shall ensure proper conduct of these personnel in the premises of MUDRA Ltd.
- X. The person deployed shall not claim any master & servant relationship against MUDRA Ltd.

6.9 Rights of MUDRA Ltd.

- i. Decision of MUDRA Ltd. in regard to interpretation of the Terms and Conditions of the Agreement shall be final and binding on the Agency.

7.10 Dealing of Offence/ Loss etc

- I. In case of any theft or pilferages, loss or other offences in the nature of fraud or otherwise, committed by the personnel emloyed by the agency, the agency will investigate and submit a report to MUDRA Ltd. and maintain liaison with the police.
